# **Privacy Policy**

# PLEASE READ THIS PRIVACY NOTICE CAREFULLY BEFORE USING THE PLATFORM VYXIA TOKENS COIN

The purpose of this notice is to provide you with information on our use of your personal data in accordance with the Data Protection Law. In this document, "we", "us" and "our" refers to VYXIA Tokens DeFi. (together the "Company") and its affiliates and/or delegates. This Privacy Notice describes our information handling practices when you access our services, services, which include our content on the website located at <a href="www.vyxia.world">www.vyxiatokens.world</a>

### 1. Acceptance of this Privacy Notice

By accessing and using our Website, you signify acceptance to the terms of this Privacy Notice. If you do not agree with or you are not comfortable with any aspect of this Privacy Notice, you should immediately discontinue access or use of our Services.

#### 2. Data

By virtue of accessing a Company Website and your associated interactions with us (including any subscription (whether past, present of future), including the recording of electronic communications or phone calls where applicable) or by virtue of you otherwise providing us with personal information, you will provide us with certain personal information which constitutes personal data within the meaning of the DPL ("Data"). We may also obtain Data from other public sources. #### 1. How We May Use Your Personal Data

The Company, as the data controller, may collect, store and use Data for lawful purposes, including, in particular:

- where this is necessary for the performance of our rights and obligations under the Subscription Agreement and/or the constitutional and operational documents of the Company;
- where this is necessary for compliance with a legal and regulatory obligation to which the Company is subject (such as compliance with anti-money laundering and FATCA/CRS requirements); and/or
- where this is necessary for the purposes of our legitimate interests and such interests are not overridden by your interests, fundamental rights or freedoms.

2. Should we wish to use Data for other specific purposes (including, if applicable, any purpose that requires your consent), we will contact you.

#### 1. Who this Affects

If you are a natural person, this will affect you directly. If you are a corporate body (including, for these purposes, legal arrangements such as trusts or exempted limited partnerships) that provides us with Data on individuals connected to you for any reason in relation to your interactions with us, this will be relevant for those individuals and you should transmit this document to such individuals or otherwise advise them of its content.

#### 2. Why We May Transfer Your Personal Data

In certain circumstances we and/or our authorized affiliates or delegates may be legally obliged to share Data and other information with respect to your interactions with the Company with the relevant regulatory authorities. They, in turn, may exchange this information with foreign authorities, including tax authorities.

## 4. Information we Collect Automatically

To the extent permitted under the applicable law, we may collect certain types of information automatically, such as whenever you interact with the Website or use the Services. This information helps us address customer support issues, improve the performance of our Website and applications, and satisfies our regulatory obligations. Information collected automatically includes:

\*Online Identifiers. This includes, but is not limited to, geo location / tracking details, browser fingerprint, operating system, browser name and version, and / or personal IP addresses.

\*Usage Data: Authentication data, security questions, click-stream data, public social networking posts, and other data collected via cookies and similar technologies. Please read our <a href="Cookie Policy">Cookie Policy</a> for more information.

For example, we may automatically receive and record the following information on our server logs :

- How you came to and use the Services;
- Device type and unique device identification numbers;
- Device event information (such as crashed, system activity and hardware settings, browser type, browser language, the date and time of your request and referral URL);

- How your device interacts with our Website and Services, including pages accessed and links clicked;
- o Broad geographic location (ex. country or city location); and
- Other technical date collected through cookies, pixel tags and other similar technologies that uniquely identify your browser.

## 6. Data Aggregation

VYXIA Tokens may anonymize or aggregate date we collect for any business purpose, including to better understand user needs and behaviors.

7. We may also use identifiers to recognize you when you access our Website via an external link, such as a link appearing on a third-party website.

## 8. Information we collect from third-parties

We may obtain information from third party sources as required or permitted by applicable law. We may analyze public blockchain data to ensure parties accessing our Website are not engaged in illegal or prohibited activity under our Terms of Use, and to analyze transaction trends for research purposes.

#### 9. Operations

VYXIA operates independently, aligning with the business model principles of Bitcoin and other cryptocurrency tokens/coins. There are no binding regulations, no legal constraints, and no entity can impede this business's movement and growth. Blockchain computing and advancements in Web3 technology make it possible for VYXIA to function without the need for approvals from regulatory bodies or government entities and without being subject to any country's financial or global economic rules. VYXIA World, VYXIA Tokens, and all brands or entities within the VYXIA group—including VYXIA World and VYXIA Tokens—do not fall under the regulations of Indonesia, Asia, or any other nation, nor are they governed by government officials, institutions, law enforcement, or any judicial authorities. Accordingly, all users, members, leaders, and participants within VYXIA, in full awareness and without any coercion, agree to release any and all claims against VYXIA's founders, leaders, or management in cases of losses or risks associated with investment and force majeure. All risks are borne solely by each user and participant. These terms and conditions are outlined prior to registration. We shall notify you of any Data breach that is reasonably likely to result in a risk to the interests, fundamental rights or freedoms of either you or those data subjects to whom the relevant Data relates.
